#### New Agriculture Bills for 2023

Ag and Ag Related Bills Going into Effect for Illinois in 2023 include the following:

**HB 05400** Allows the Illinois Department of Agriculture to issue Future Farmers of America decals for Universal special license plates.

**HB 05201** Establishes the Agriculture Equity Commission to bring equity to the top job-producing industry in the state. Recognizes the current struggles minority-farmers experience in the industry.

**SB 03838** Allows local health departments to use a specific Farmers Market Permit to regulate the sale of certain potentially hazardous foods as well as products raised or grown on the farm of the farmer selling the food product.

**HB 03118** Prohibits commercial applicators from applying a barrier mosquitocide between Oct. 16 and April 14 unless it's for public health purposes or the Department of Agriculture determines there is a significant unmet need.

#### March 6th

#### 2023 Bills that impact the seed industry

March 10th is the deadline for bills to get out of committee in the Illinois State Capitol. Below are bills that have the most impact on the seed industry. ISTA will be actively working with senators and representatives to make sure our voice is heard on these important legislative issues. As of today, there are 6,538 new pieces of legislation at the capitol. ISTA is actively watching and working over 35 pieces of legislation. Below are the bills that have the most impact to our industry.

## Seed Related Legislation

**HB1440** - PRETREATED SEED BAN-ETHANOL, Amends the Illinois Pesticide Act. Provides that, notwithstanding any other provision of law, no person shall produce ethanol using seeds that have been treated with a pesticide. ISTA is Monitoring HB1440. HB1440 passed out of the House Environment Committee on a 17-8 vote. HB1440 now moves to the House floor.

**HB3726** - DISPOSAL OF PRETREATED SEEDS, Amends the Illinois Pesticide Act. Provides that any manufactured seed that has been treated with a pesticide and that is to be disposed of must be disposed of at a permitted hazardous waste disposal site. ISTA Opposes HB3726. HB3726 has been assigned to House AG Committee.

#### Pesticide Related Legislation

**HB2254** - SB203 - PESTICIDES-PENALTIES, Amends the Illinois Pesticide Act. Provides that for any person applying a pesticide that results in exposure to the pesticide by a human, the penalty shall be \$2,500. Provides that an additional penalty of \$1,000 shall be assessed for each individual human exposed to the pesticide. HB2254 has been assigned to House Environment Committee. SB203 has been assigned to Senate Ag Committee.

**HB3086** - SB1726 - PESTICIDES-REGISTRATION, Amends the Illinois Pesticide Act. Increases various fees imposed under the Act beginning in 2024. Provides that all pesticide license fees go to \$250 (rather than \$100). HB3086 has been assigned to House Environment Committee. SB1726 has been assigned to Senate Ag Committee.

**HB3800** - RESTRICTED USE PESTICIDES, Amends the Illinois Pesticide Act. Provides that the definition of "Restricted Use Pesticide" also includes any pesticide with one or more of its uses classified as restricted by order of the Director of the Illinois Department of Agriculture or any pesticide containing Dicamba (3,6-dichloro-2-methoxybenzoic acid) or 2,4-D (2,4-dichlorophenoxyacetic acid). HB3800 has been assigned to House Environment Committee.

**SB187** - PESTICIDES-NEONICOTINOIDS, Amends the Illinois Pesticide Act. Provides that, on and after January 1, 2024, no pesticide containing a neonicotinoid may be used outdoors on any land owned or maintained by the State, except for use in structural pest control or abatement of non-native insect borers, subject to specified restrictions. Provides that the provisions do not prohibit: the use of seeds that are pretreated with neonicotinoids on public lands owned or maintained by the State; the use of neonicotinoids on property belonging to a public institution of higher education; or the use of neonicotinoids for wood preservation. Defines "neonicotinoid". Provides that "Restricted Use Pesticide" does not include a pesticide containing a neonicotinoid that is applied by a licensed applicator or certified technician working in structural pest control. SB187 has been assigned to Senate Ag Committee.

## **Trucking Related Legislation**

HB1634 - CALIFORNIA EMISSION STANDARDS FOR All VEHICLES, Amends the Vehicle Emissions Inspection Law of 2005 of the Illinois Vehicle Code. Provides that, by December 1, 2023, the Illinois Environmental Protection Agency shall adopt rules to implement the motor vehicle emission standards of the State of California, including, 1) zero-emission vehicle program, (2) low-emission vehicle program, (3) advanced clean trucks program, and (4) heavy-duty low NOx omnibus program. HB1634 hasn't been assigned to committee.

**HB2505** - SB2278 - TRUCK MAX HEIGHT / WEIGHT, Amends the Illinois Vehicle Code. Provides that local authorities with respect to highways under their jurisdiction may also, by ordinance or resolution, prohibit the operation of trucks or other commercial vehicles, or may impose limitations as the weight, height, or length (rather than only weight). HB2505 has been House Transportation Committee. SB2278 has been assigned to Senate Transportation Committee.

## **PFAS Related Legislation**

There's quite a bit of PFAS related legislation in this General Assembly this spring. None of them directly affect the seed trade industry. We will keep you aware if there's new amendments to any of those pieces of legislation that will directly affect our industry.

## March 16th

#### 2023 Spring Session UPDATE

March 10th was the deadline for bills to get out of committee in the Illinois State Capitol. Below is an update on the Spring Session.

#### Seed Related Legislation

**HB1440** - PRETREATED SEED BAN-ETHANOL, Amends the Illinois Pesticide Act. Provides that, notwithstanding any other provision of law, no person shall produce ethanol using seeds that have been treated with a pesticide. ISTA is Monitoring HB1440. HB1440 passed out of the House Environment Committee on a 17-8 vote. HB1440 now moves to the House floor.

**HB3726** - DISPOSAL OF PRETREATED SEEDS, Amends the Illinois Pesticide Act. Provides that any manufactured seed that has been treated with a pesticide and that is to be disposed of must be disposed of at a permitted hazardous waste disposal site. ISTA Opposes HB3726. HB3800 was not called in the House Environment Committee.

#### April 11th

#### Department of Labor Makes H-2A Program Changes On March 28th the Agricultural Workforce Coalition (AWC) issued a letter addressed to Congressional Leaders in Washington regarding changes the Department of Labor has made to the H2A program. Changes in the fee structure, fees that apply in the event of an extended season and job coding concerns have prompted the letter. The AWC is calling for resolutions to

disapprove of the Department of Labor's (DOL's) new and harmful H-2A regulation, entitled, "Adverse Effect Wage Rate Methodology for the Temporary Employment of H-2A Nonimmigrants in Non-Range Occupations in the United States." In the letter the AWC states that "The DOL's regulation comes at a time when American farmers are reeling due to record high costs of production that have translated into thin and even negative margins, conditions the new regulation will greatly exacerbate. Moreover, the regulation further complicates an already complex program and creates legal uncertainty for farmers who comply with requirements in good faith. The Department of Labor has also managed to develop a regulation that it, too, will have great difficulty administering, making the program even more cumbersome for farmers, many of whom produce perishable goods whose handling cannot wait on a bureaucracy." # ISTA A.L Lang and W.L Burlison Memorial Scholarship Fund.

The Illinois Seed Trade Association met with representatives from the University of Illinois Foundation earlier this year. The board of directors then set the course for amending and restating the Lang endowment. The fund will now be known as the Illinois Seed Trade Association A. L. LANG and W. L. **BURLISON Memorial Scholarship Fund. Scholarships will** now be awarded to undergraduate students in the Department of Crop Sciences. The recipients will be selected by the department head in counsel with members of the department. Candidates must demonstrate scholarship, leadership, and evidence of professional promise.

In honor of Dr. Burlison and Professor Lang please take a few minutes to read the following bioagraphies by James R. Shearl, ISTA Member. Jim points out that Burlison and Lang only disagreed on one thing - the game of golf.

#### Dr. W. L. Burlison

Dr. William L. Burlison (1882-1958) was an internationally acclaimed agronomist. He did both his masters and PhD at the University of IL and then became an associate professor in the U of I Department of Agronomy in 1915. He advanced to full professor in 1920 and served as Head of the Department of Agronomy until his retirement in 1951. Burlison published bulletins, circulars, scientific articles including one book called Farm Crop Projects. Burlison was an early promoter of the diverse use of many crops. He was one of the developers of the American Soybean Association in 1920 and a founder of the National Soybean Processing Association in 1930. Burlison promoted many uses of soybeans including edible varieties, as well as oil and protein uses. It was fitting that in 1988, Dr. Cecil Nickel released a high performing, high protein soybean variety and named it Burlison. Jim Shearl was developing the ICIA Grain Quality Lab at the release of Burlison. Shearl saw the high protein merit and worked with certified seed producers in the Gibson City, IL area and coordinated the delivery of 100,000 bushel of identity preserved Burlison to Central Soya of Gibson City for special use processing.

#### Professor A. L. Lang

Professor Alvin L. Lang (1896-1989) was raised in Elmwood, IL. He was an outstanding athlete and lettered at the U of I as a pole vaulter. He received his undergraduate degree from the U of I in 1920. He immediately started working for the U of I Department of Agronomy. He worked both as an experiment station leader at Dixon, IL and as a teaching and research professor on the Urbana campus. His professorial specialization was soil science. After retiring from the University of IL, he became Executive Secretary of the IL Seed Dealer's Association (ISDA) now the IL Seed Trade Association. Al was an excellent photographer. His agricultural pictures were used in many high school textbooks. He also was a regular photo contributor to the IL Seed News. In addition, he was the author of 50 Years of Service IL Crop Improvement Association. Two of Al's greatest achievements for ISDA were hiring a lobbyist to assist the IL seed industry and being a founding member and serving as secretary of the IL Ag Legislative Breakfast.

#### Working Together Again... Lang and Burlison

Al Lang had tremendous respect for Doc Burlison as he called him. Burlison was Department Head and Al's boss. Burlison was strict. He expected everyone to wear a necktie, be on time or early, and working on Saturday was encouraged. Burlison was a teacher and a promoter. Al would say "Ole Doc Burlison always said - you have to get out and be seen." In other words, don't just sit behind your desk.

Burlison and Lang only disagreed on one thing. Burlison thought the game of golf was a big waste of time. They would both laugh that the scholarship funds raised in their honor are over a game of golf. On the other hand, they were both very dedicated to scholarships. They would like this scholarship being named after them both.

#### Legislative Updates

The spring session is set to end on May 19th. All attention has turned to the state budget. Legislation of interest to the seed industry are listed below.

**HB1440** - PRETREATED SEED BAN-ETHANOL, Amends the Illinois Pesticide Act. Provides that, notwithstanding any other provision of law, no person shall produce ethanol using seeds that have been treated with a pesticide. HB1440 passed out of the House on a 77-36 vote.

**HB3726** - DISPOSAL OF PRETREATED SEEDS, Amends the Illinois Pesticide Act. Provides that any manufactured seed that has been treated with a pesticide and that is to be disposed of must be disposed of at a permitted hazardous waste disposal site. HB3726 was not called in House AG Committee.

**HB3800** - RESTRICTED USE PESTICIDES, Amends the Illinois Pesticide Act. Provides that the defining of "Restricted Use Pesticide" also includes any pesticide with one or more of its uses classified as restricted by order of the Director of the Illinois Department of Agriculture or any pesticide containing Dicamba (3,6-dichloro-2-methoxybenzoic acid) or 2,4-D (2,4-dichlorophenoxyacetic acid). HB3800 was not called in House Environment Committee.

#### In case you missed it! (May)

Mexico has revised its ban on GM corn, but the discussions are still ongoing. "The new decree, modified and issued in

February 2023, eliminated the deadline to ban GM corn for animal feed and industrial use— the new decree instead retains plans to prohibit use of grain for human consumption, as well as the glyphosate ban. In addition, the new decree also continues to maintain the prohibition of planting GM corn on Mexican soil." Read more at <u>SeedWorld</u>.

Leaders from Bioceres Crop Solutions were in D.C. recently to meet with stakeholders regarding the intended commercial cultivation of their drought tolerant GM wheat in the U.S. in the next four to five years. The product is now permitted as a food item in the U.S. Grain or food containing this trait is permitted to be imported into the U.S. with no regulatory restrictions. Cultivation approvals for the HB4 wheat trait are still under development.

NAMA joined other agriculture and university stakeholders in supporting \$2.5 million for aflatoxin mitigation research by the USDA Agricultural Research Service in FY 2024. The <u>letter notes</u> that climate change will further exacerbate the aflatoxin problem in corn. Research by Kansas State and three other universities suggests that 89.5% of corn-growing counties in 15 U.S. states will experience increased aflatoxin contamination from 2031 to 2040. Read more at Farm Progress.

An additional 20,000 acres were added to the 2023 Fall Cover for Spring Savings program in Illinois. According to Director Costello the applied-for acreage set a record of 182,688 acres (Jan.15 deadline). The additional acreage announced by the Illinois Department of Agriculture brings the available acreage to 160,000. Read more at Farm Week.

A Look Back at the Objectives of the Committee In 1985 the following objectives were established by the Illinois Seed Trade Association.

#### Seed Analyst Liaison Committee Objectives:

**1.** Discuss and aid in problems concerning agricultural seeds.

2. Hold seminars as needed for seed testing problems.

**3.** Assist seed producers when agricultural seed problems arise.

The objectives and responsibilities were expanded in subsequent years to include the following.

Functions of ISTA Liaison Committee Seed Analysts: **1.** To meet at least twice yearly.

**2.** Review problems arising in seed analytic laboratories within the state and with interstate commerce.

**3.** Promote means of solving the problems through workshops, referee samples, laboratory visitation, and general meetings.

**4.** Establish rules or guidelines by which the committee operates.

**5.** Elect necessary officers to carry out the functions of the committee.

**6.** Report to the Board of Directors of ISTA, the actions of the committee at the regular meeting of the board preceding the annual meeting of ISTA. Specifically, the incoming president of ISTA needs to know the officers and members of the Liaison Committee in order to complete his list of committees for publishing in the membership list of ISTA.

**7.** The chairman of the Liaison Committee should report all meetings and either the original or a copy of such reports should go to the office of the ISTA Executive Secretary-Treasurer for filing as permanent records of the association.

In a press release the USDA stated that it is "removing Soybeans of Other Colors (SBOC)" as an official grade-determining factor. The decision was "based on numerous requests from representatives of U.S. soybean producers and grain traders" The change is effective September 1, 2023. The analysis showed that 7% of the test results were out of tolerance. Considering the wide range of experience and staff changes at participating laboratories over the past seven years, the referee participants are striving for fair and equitable results for the seed trade.

The audience included almost forty seed industry professionals from nine companies. The committee and ISTA Board of Directors thank the speakers and participants who shared their time, expertise, and perspectives on seed testing.

## September 12th

## High Plains Wheat Mosaic Virus (HPWMoV) Request for Funding.

The Seed Science Foundation (SSF) is requesting funding from the seed industry for some critical work. The work aims to keep winter locations like Chile a viable option for everyone in the industry, from plant breeders to seed producers. According to a recent email from the SSF, the "Systematic investigation of the risk of seed transmission of HPWMoV is urgently needed to inform phytosanitary requirements for U.S. seed trade and export and develop management or mitigation strategies." The SSF is requesting seed companies to consider supporting this key research through a 3-year commitment of funds. The SSF will match dollar-for-dollar the total funding commitment made by SSF members, up to \$30,000 per year. Please consider the importance of this research and its potential impact on the continuance of pipeline advancements, corn seed production, and delivery. The SSF has set a deadline of December 1, 2023 to follow-up with the researchers regarding the SSF's funding commitment. Please confirm your funding commitment with Sam Thomas (SSF Research Chair) or Ric Dunkle (ASTA Seed Health Director) by November 15. Please get in touch with Doug Miller or Amber Sheets if you need Sam or Ric's contact information. This work will better position the industry in its response to mitigating the HPWMoV impact and facilitate conversations regarding seed movement with key import and export NPPOs.

#### In case you missed it! (September)

Illinois rose to the No. 6 wheat-producing state in the nation this year with a record yield of 84 bushels per acre. Illinois farmers harvested 65.5 million bushels of wheat this summer, up 48% compared to the previous crop. Read more about Illinois Wheat at <u>Farm Week</u>.

NAMA recently shared that U.S. wheat exports for the 2022-23 crop year will reach only 700 million bushels of hard red wheat (HRW)—a 52-year low. Conversely, soft red wheat (SRW) shows a record 170 million bushels used for food. The price spread between SRW and HRW, along with the higher protein levels of HRW in drought-stricken regions of the Great Plains, is expected to encourage blending by Millers to achieve target protein levels. Bayer will contribute \$500,000 to fire relief efforts on the island Maui – a cash donation of \$250,000 alongside a

donation of essential healthcare products valued at \$250,000 under its vision, 'Health for All, Hunger for None.' Read more at <u>Seed Today</u>.

Bacteria have been evolving genetic mechanisms to cope with stress for millions of years. Micro and nano-plastics in soils from mulch lining vegetable beds, PVC pipes, polyethylene coverings, and other plastics may evoke genetic changes in bacteria. Pratik Banerjee, associate professor in FSHN and Illinois Extension specialist, shared with Lab Manager that, "We have also shown bacteria may become more virulent in the presence of plastics, in addition to becoming more resistant to antimicrobials." So far, the phenomenon has been documented in water or aqueous environments and is only hypothetical in agricultural soil. The authors point out that many foodborne pathogens make it onto produce from their native home in the soil. Still, nano-plastics and antibioticresistant bacteria could be small enough to enter roots and plant tissues—where they are impossible to wash away. The topic of micro and nano-plastics is being addressed by ASTA's Seed Treatment and Environment Committee. Read more at Lab Manager.

The Illinois Soybean Association (ISA) recently commented on Neonicotinoids in a recent legislative update. ISA shared that "When introduced, neonics proved to be more effective than other insecticides on the market. They [neonics] often replaced more toxic alternatives and helped minimize the potential for environmental exposure to non-target species." The Illinois Soybean Association update went on to say that 80% of soybeans and 90% of corn seed have a neonic seed coating" and "In recent years, farmers and manufacturers have made considerable efforts to minimize any further risk of exposure to nontarget insects."

#### October 17th

#### **Treated Article Exemption**

ISTA has received advance notice from ASTA of a proposed EPA rule that could directly impact the Treated Article Exemption for seed. The Treated Article Exemption is the lynchpin to the seed industry's use of registered pesticides. Please let us know if you would like to provide any input or comments. #### EPA and the Endangered Species List

The Illinois Soybean Growers (ISG) is circulating a petition in an effort to push back on the EPA's proposed herbicide strategy to be implemented by 2024. Among other details, the "ISG is most concerned about a new policy on fields with subsurface drainage (tile drainage), which would require construction of wetlands/retention ponds to prevent all drainage (water) from flowing off-site." Additional points of concern include criminal penalties, incentivizing a surveillance state, establishing pesticide exclusion zones, and increasing drift buffers. This is a total of 24 survey responses based on a full participation level of 3 crops x 2 test types x 4 months. This method provides the best download from the system for analysis.
